#### FEES PAYABLE TO THE DEANERY

These fees are payable in respect of any service specified below, conducted by an Anglican priest at any venue other than in an Anglican church. For the avoidance of doubt the Chapels of St. Tugual, St. Apolline and Christ The Healer are not, for the purposes of this provision, classified as Anglican churches.

#### Service at St. Tugual's Chapel

The fee for the solemnisation of a marriage will be collected on behalf of the Deanery by the Ecclesiastical Court when notice of the marriage is given. With regard to the fee payable for a service of thanksgiving after a civil marriage ceremony, it is the duty of the officiating priest to collect the fee on behalf of the Deanery.

#### **Priest's Travel Expenses**

Travel expenses are payable to the officiating minister in respect of marriages or services of thanksgiving conducted at any venue other than in an Anglican church, save that for services held at St. Tugual's Chapel the travel expenses shall be £50.

These fees are payable in respect of any service specified below, conducted by an Anglican priest, deacon or licensed lay minister.

NOTE: No fee is payable for the burial of a stillborn infant or persons aged under 18 years.

# **Organists' Fees for Marriages & Funerals**

These are fixed by each organist but a guide is a minimum of £84.

## Signing Cremation Papers

Fee payable to clergy for signing cremation papers 34

Each Sunday service	£ 50 (max. £100 per Sunday)
Each weekday service	£ 34
Separate baptisms	£ 50
Marriages	£162
Funerals	£ 84
Burial of body or ashes on separate occasion	£ 42

These fees are payable to clergy "with permission to officiate" only. Beneficed clergy, selfsupporting ministers and licensed lay ministers are **not** entitled to a fee. All of the above fees may be claimed from the Treasurer of the church concerned but for funerals etc. held in a venue other than in an Anglican church, the claim shall be submitted to the Deanery Treasurer.

#### Travel Expenses

Travel expenses should be offered to all clergy and readers officiating at services (other than when specific provision is made in this Table of Fees) as follows:

•	Car	66p per mile
•	Motorcycle	33p per mile
•	Bicvcle	12p per mile
