

## Fees for Clergy

### PART A – OCCASIONAL OFFICES

Holy Baptism (separate service)	£ 60
Marriage or Service after civil ceremony	£191
Herm Marriage or Service after civil ceremony	£384
Funeral	£102
Burial of body or cremated remains on separate occasion	£ 51

The fees set out in Part A are payable to all clergy **other than those in receipt of a full stipend**. All such fees may be claimed from the Treasurer of the church concerned but for services held in a venue other than in an Anglican church, the claim shall be submitted to the Deanery Treasurer.

### PART B – SUNDAY AND WEEKDAY SERVICES

Each service with sermon	£ 60
Each service without sermon	£ 40

The fees set out in Part B are payable to all clergy **other than those in receipt of a full stipend**. All such fees may be claimed from the Treasurer of the church concerned.

N.B. The Part B fees are not payable for services taken in the priest's base church(es).

## Travel Expenses

Travel expenses, as determined from time to time by the Guernsey Deanery Board of Finance LBG, should be offered to all clergy and readers officiating at services (other than when specific provision is made in this Table of Fees).

### FEES PAYABLE TO THE DEANERY

These fees are payable in respect of any service specified below, conducted by an Anglican priest at any venue other than in an Anglican church. For the avoidance of doubt the Chapels of St. Tugual, St. Apolline and Christ The Healer are not, for the purposes of this provision, classified as Anglican churches.

#### Service at any venue on the island of Herm

Solemnisation of a marriage	652 *
Service of thanksgiving after a civil marriage ceremony	652 *
<i>* includes travel expenses of £59 payable to the officiating priest.</i>	

#### Service at all other Bailiwick venues not being Anglican churches

Solemnisation of a marriage	322 *
Service of thanksgiving after a civil ceremony	322 *
<i>* includes travel expenses of £25 payable to the officiating priest.</i>	

The fee for the solemnisation of a marriage at venues other than Anglican churches, will be collected on behalf of the Deanery by the Ecclesiastical Court when notice of the marriage is given. With regard to the fee payable for a service of thanksgiving after a civil ceremony at venues other than Anglican churches, it is the duty of the officiating priest to collect the fee on behalf of the Deanery.

In addition to the aforementioned fees, fees are payable to the Ecclesiastical Court for a Marriage Licence.

## Funerals and Memorial Services

**Minister's travel expenses** **25**

Travel expenses are payable to the officiating minister in respect of all the following services.

### FEES PAYABLE TO THE DEANERY

**These fees are payable in respect of any service specified below, conducted by an Anglican priest, deacon or licensed lay minister.**

Service in churchyard, crematorium, parochial cemetery or other venue	134
Burial of body or cremated remains in churchyard, parochial cemetery on separate occasion	67
Deposit of cremated remains in columbarium in churchyard, parochial cemetery on separate occasion	67

NB: No fee is payable for the burial of a stillborn infant or persons aged under 18 years.

## Organists' Fees for Marriages & Funerals

These are fixed by each organist but a *guide* is a minimum of £100.

## Signing Cremation Papers

Fee payable to clergy for signing cremation papers – £40
